First off, I hope all of you survived Hurricane Beryl with minimal damage to you and your properties. I know the city has started to collect tree debris in the streets so hoping to have our streets debris free soon.

# The Timeline for Hurricane Beryl KPTA cleanup

July 8<sup>th</sup> Monday, Hurricane Beryl makes landfall

July 12<sup>th</sup> Friday – Directors began to survey their sections for cleanup

### Phase 1 - Clearing trail paths - completed

July 12<sup>th</sup>, contracted with our landscape contractor to begin discussion on clearing the trail along Kingwood Drive

July 15<sup>th</sup> – 23<sup>rd</sup> – Path clearing with Forest Tree Service and CC Lawn Maintenance. Each contractor had additional crews to speed up the process of path clearing.

July 23<sup>trd</sup> – last tree debris removed from the trail paths; all 11 miles of trails are open.

July 31 – Aug 1 – Cleaned debris from Kingwood Drive Esplanade

Aug 5 – Scenic Shore-Lake Houston, bringing downed trees and debris to curb for city pickup

# Phase 2 - In Progress

Survey of the trails for overhead hazards, trail damage, overview of Phase 3 work to be done – trail ride completed – summarizing information for next steps.

### Phase 3 – Anticipated to begin mid to late August

We are waiting for Forest Tree Service and CC Lawn Maintenance current work orders to be completed. Once completed they will begin the final phase of cleanup.

### Message from Gene Morris, Treasurer

We know that many of you saw the effects of Beryl on the trails. The result was so devastating that most of the trails were not safe or passable. Initial damage from Beryl to the trails included downed trees, dangerous trees, limbs of various sizes, overhead hazards, damage to the trail's walkway, and various debris.

It was apparent that KPTA would have to use its financial resources to return the trails to its usual condition as soon as possible. Thanks to a reserve cash fund, and with a lot of work and skill of our



expectation of more invoices to come.
